## DECLARATION OF INTEREST FORM

The public is entitled to expect the highest standards of conduct from the King's Lynn Town Board (KLTB) as outlined by the Department for Levelling Up, Housing and Communities (DLUHC). It is recognised that the integrity of the Board rests on mutual trust and respect between Members and members organisations. Borough Council of King's Lynn & West Norfolk (BCKLWN) places particular emphasis on the quality of this relationship and undertakes to maintain a climate in which mutual trust and respect can thrive. As part of this process it is important that staff make any necessary declarations of interest.

KLTB members must give notice in writing of any financial or non-financial interests which are clear and substantial and which could bring about a conflict with the Board and BCKLWN's interests.

In addition, membership or acting as an officer (honorary or otherwise) of any secret society (as defined below) should be notified in writing as above whether or not a demonstrable conflict of interest with the KLTB or BCKLWN's interests arises or may arise.

For the purposes of the Code of Conduct, a secret society is defined as being:

Any lodge, chapter, society, trust, regular gathering or meeting, which;

- is not open to members of the public who are not members of that lodge, chapter, society, trust, regular gathering or meeting;
- includes in the grant of membership an obligation on the part of the member with a requirement to make a commitment (whether by oath or otherwise) of allegiance to the lodge, chapter, society, trust, regular gathering or meeting; and
- includes, whether initially or subsequently, a commitment (whether by oath or otherwise) of secrecy about the rules, membership or conduct of the lodge, chapter, society, trust, regular gathering or meeting.

All interests recorded by BCKLWN are logged in a register of declarations of interest which is maintained by the council's Monitoring Officer and in the interests of openness and transparency, will be available for public inspection on the website.
